Rules

1. Entries will be accepted until 5pm on May 12, 2022. Entry fee is non-refundable.
2. Entries will be accepted from 5am – 6am at Yarborough Landing.
3. This will be an “On Your Hole” start. Live-well checks will start at 4:30am.
4. Trailering is allowed after check-in and Live Well check at Yarborough Landing. However, all fish weighed must be from your boat on the water.
5. Fishing will begin at 6am with final weigh-in at 2:00pm (weigh-in line will close at 2:30pm).
6. Winner will be determined by total weight of single fish. Hourly winners are eligible for the overall prize.
7. All fish must be caught the day of the tournament with a fishing pole and artificial lures. There is no maximum number of poles allowed.
8. All persons on a boat must be registered and paid for the tournament.
9. Only live fish will be presented for weigh-in.
10. Each angler can present only 1 fish per hour to be weighed.
11. Anglers are prohibited from having digital contact with members of the tournament committee during tournament hours.
12. All state and federal rules and regulations must be observed.
13. Consumption of alcohol or unsportsmanlike conduct during tournament hours will result in disqualification.
14. Life jackets must be worn while engine is above fast idle.
15. Tournament committee decisions will be final in all matters. Winners may be subjected to, and pass, a polygraph test.
16. Ties will be determined by first fish weighed.
17. Any protest must be made in writing within 15 minutes of weigh-in line closing to the tournament committee.
